#### **Description of the Proposals:**

Severance Consent Application B16/2025 proposes a lot line adjustment / lot addition from the originating parcel known as 250 Richardson Road, Roll # 14 35 229 040 09504 0000 to 226 Richardson Road, Roll #14 35 134 229 040 09505 0000. Approximately 2.60 acres (1.05 hectares) from the originating parcel will be severed and merge with the adjacent parcel to the south, described as 226 Richardson Road. The benefitting parcel's current size is approximately 12.62 acres (5.11 hectares) with an existing residential dwelling. The overall proposed parcel size will be 15.22 acres (6.16 hectares), once the lot line adjustment / lot addition is completed.

The retained portion of the originating parcel, being approximately 2.00 acres (0.80 hectares), contains an existing residential dwelling, fronting on Richardson Road.

# Planning Act:

## **Purpose of the Public Hearing:**

The Public Hearing is held in accordance with the requirements of the Planning Act. The purpose of the meeting is for Council Members to formally hear and receive public and agency comments. The intent of this statutory Public Hearing is to receive public feedback and incorporate it into a recommendation report from Staff. No decision will be made during this meeting.

## Written comments (via email or in writing) before a meeting:

Individuals who submit a letter and other information to Council should be aware that all information, including contact information, contained within their communications may become part of the public record and may be made available through the agenda process which includes publication on the Municipality's website.

There is a 20-day appeal period after a decision has been made. Please note, however, only the applicant, the Municipality, certain public bodies, and the Minister may appeal the decision. In order to appeal the decision to the Ontario Land Tribunal (OLT), those eligible must submit the required form to the Municipality of Trent Hills including the applicable appeal fee paid by certified cheque or money order, made payable to the Ontario Minister of Finance.

#### Attending in-person:

The Public Hearing will be open for the public to attend in person in the Council Chambers located on the 2<sup>nd</sup> floor of the Emergency Services Base, 50 Doxsee Avenue South, Campbellford.

## Attending virtually:

Members of the public and the applicants will also be able to participate in Public Hearings through Zoom. Interested residents and applicants can register by emailing <a href="mailto:planning@trenthills.ca">planning@trenthills.ca</a> with their name, phone number, and the agenda item(s) they wish to speak to, or by calling 705-653-1900 and leaving a message with their name, phone number, and the agenda item(s) they wish to speak to. Those who have registered will be provided with the Zoom meeting information prior to the meeting date. Registration will close by 4:00 p.m., the day prior to the meeting.

The Public Hearings will be live streamed, available through the Municipality of Trent Hills <a href="www.trenthills.ca">www.trenthills.ca</a>. The video will also be posted online following the meeting in the event you were unable to watch it live at the time it occurred.

#### How to ask a question during the meeting:

The Chair of the meeting will open the floor to public comments. Those wishing to speak will identify themselves and will be placed in queue to provide comments at the podium. Please state your name and address for the public record.

Those registered to participate virtually will be able to provide comments and ask questions during the Public Hearing in the same manner as in-person meetings. Please identify yourself and you will be placed in queue to provide comments. Please state your name and address for the public record.

If required, instructions will be provided to members of the public who have registered to participate in the Public Hearing.

## How to submit comments after a meeting:

You may submit comments following the Public Hearing, you may email your comments to <a href="mailto:planning@trenthills.ca">planning@trenthills.ca</a>. The Municipality requires these comments no later than seven (7) days after the meeting to ensure the comments can be reviewed by Planning Staff before they prepare a final recommendation report to Council.
