

Notice of Study Commencement Addendum to Schedule 'B' Municipal Class Environmental Assessment for Servicing for the Campbellford Business Park

The Municipality of Trent Hills has initiated an Addendum to the Schedule "B" Municipal Class Environmental Assessment (MCEA) for the Campbellford Business Park (CBP) that was completed in 2005. The original 2005 MCEA study aimed to develop a master servicing plan for a business park development on lands owned by the Municipality in Campbellford Ontario. The servicing plan was organized into three (3) phases, with Phase 1 constructed in 2010 and the servicing of Phases 2 and 3 are not yet completed.

The purpose of this Addendum is to provide an updated servicing plan for the Phase 2 and 3 areas of the CBP to reflect the current MCEA process, current site conditions and the current policy framework established by Provincial and local approval agencies.




Figure 1: General Study Area for the MCEA Addendum

The study area encompasses 13 hectares (ha) of municipal property and surrounding lands located in the southern portion of Campbellford. The site is bounded by County Road 30, Industrial Drive / Ranney Gorge Drive and 5th Line West (see **Figure 1**). The Municipality's objective is to service the remaining undeveloped municipally owned land to support:

- The development of a municipal Recreation and Wellness Centre on a 2.3 ha portion of the site fronting 5th Line West; and
- The creation of serviced employment/industrial parcels that can be made available for sale to developers or private businesses on 3-4 ha of land.

The balance of the site would be used to support necessary municipal infrastructure or remain undeveloped relative to environmental features and a closed landfill that are also located on or adjacent to the municipally owned property.

An important component of this study will be agency and public consultation. One Public Information Centre (PIC) will be held to present the study progress, advise of any changes since the 2005 filing and obtain public input. With the exception of personal information, all comments received will become part of the public record, in accordance with the *Freedom of Information and Protection of Privacy Act.*
